The deposit signifies intent on the behalf of the purchaser to follow through with the purchase transaction of the puppy. In the event that the Purchaser cannot follow through with the purchase of the puppy, the all deposits will be forfeited and NO refund will be given. If the puppy you choose, *by the decision of PTK Ranch LLC*, does not end up being fit, healthy enough, or ready to take possession by the 10<sup>th</sup> week of age, purchaser may choose to transfer their funds to another available puppy, a future litter, or receive a refund of the *all funds paid up to the Purchase Price*. In the event that this would occur, PTK Ranch LLC must be notified in writing of the decision made. PTK Ranch LLC reserves the right to void this transaction and refund any funds received, if we feel for any reason the Purchaser might not be suitable for the puppy. Refunds of any kind, may take up to 30 days to return. All sales are final and irreversible with the only exceptions being those as state above.

Purchaser has received general and breed specific care instructions (online/verbal/printed), and understands the care that is required for this individual puppy/dog, and agree to provide it.

PTK Ranch LLC makes no guarantees of your puppy's mature size, breeding quality, or permanent color markings. Puppies are secured in an "as is" state (in reference to your choice of puppy at an early age), where exact color and coat pattern may change, and personality is not apparent. Every puppy comes with a "New Home Package".

Both PTK Ranch LLC and Purchaser agree that this deposit contract and sale of this puppy is under the jurisdiction of the state of Colorado, the county of Delta.

This contract contains the entire agreement between the parties and no statement or verbal agreements made by either party that are not contained in this written contract shall be valid or binding. This contract may not be modified or altered except in writing and signed by both parties. Violations of this contract will constitute BREACH OF CONTRACT.
